

Key Capabilities

AskMe**Sign** allows you to sign documents in two ways: **quick signature** or through a **signature workflow**.


You can upload documents directly from your device or select them from external systems such as **Dropbox**, **Google Drive**, and **OneDrive**.



> Sign quickly

AskMeSign allows you to sign documents in just a few clicks thanks to the "Quick Signature" feature.

Once the documents are uploaded, you can choose which signature to apply and in which areas of the document.



Create signature workflows tailored to your needs

AskMe**Sign** also enables you to **create a signature workflow**, **composed of one or more documents and one or more signers**.

The first step is to upload the documents to be signed, then select the signers: AskMe**Sign** lets you include as many people as needed in the process — one or many.

You can choose whether a document must be signed by each individual person or by role within the organization.

You can choose which and how many signatures to apply, and in which position, by inserting placeholders to fill in or to have the document completed with additional data.

AskMe**Sign** provides a predefined set of placeholders that can be freely positioned in the document, resized, oriented, and set as mandatory.



The text can be freely formatted.

As a final step, you need to select the required signature type for each signer. For digital signatures, the supported formats are **PAdES (.pdf)**, **CAdES (.p7m)** e **XAdES (.xml)**.


Streamline your work with preconfigured templates

With templates, you can define common characteristics across multiple processes (document type, signer, signature type to be applied, etc.), so you always have a ready-to-use preconfigured document ("document template") available when creating a new process.

Thanks to templates, it is possible to send documents for signature with pre-filled fields already in place.

External users can also sign from anywhere

With Interactive Public Forms (IPF) you can invite an **external signer** to sign directly via a link or by **scanning a QR code**.



> In-person signing

AskMe**Sign** allows its users to act as intermediaries. **The user can have** a **third party sign in person** (for example, a client) who is not registered in the system, by using their own personal profile and simply declaring that the signature has been provided by a third party.

Bulk sending for signature

AskMe**Sign** enables the bulk creation of signature processes, by uploading one or more documents along with a recipient list file. The group of processes is called a flow and can be monitored in a dedicated detail page.


Automatically create your workflows

AskMeSign allows you to automatically create signature processes starting from an email.



Verify signatures instantly

AskMe**Sign** enables you to check the **validity** and **compliance** of digital signatures applied to a document.



> Keep track of all your documents in a centralized archive

Each signature process is stored in the AskMe**Sign** archiving system, so you can keep track of all signed and sent documents.

Custom retention policies can be applied to the archiving system.


Documents can be retrieved through search, using multiple filters (Case ID, signers, status, signature type, ...).

AskMeSign can be integrated with any document management or certified archiving system.

Access complete audit logs

The metadata of a signature process is detailed in a document called the **Audit Log**.


The document provides both general information about the process and specific details on each individual signer.



Monitor all your activities

Real-time reporting allows you to track:

- average time spent on each signature process
- number of documents created
- percentage of documents by status


